



DISABILITY MATTERS Annual Report

Hounslow Homes has continued to strive to meet its obligations arising from the Disability Discrimination Act 2005, and to actively promote disability equality for our staff and customers by meeting best practice and providing excellent services.

One of the requirements of the act was for Hounslow Homes to produce a so called "Disability Equality Scheme" which set out how we would fulfil our duty to promote disability equality for a three year period, which we have done so, via our Disability Equality Scheme 2006-9.

Key progress made during 2006/7 includes:

- Extensive consultation & engagement of local community & voluntary groups, staff & customers to produce the Scheme itself
- Establishment of a single customer freephone (0800 085 6575) & minicom (0800 389 9821) number to improve accessibility & communication with disabled customers
- Purchasing, installation & staff training on the use of communication aids such as minicoms & portable loop systems etc
- All housing receptions & public buildings used by customers made accessible
- Signed version of a DVD introducing Hounslow Homes services produced & available to customers
- Over 50 cases of residents who have been harassed due to their disability successfully resolved by the ASB Team
- Regular quarterly monitoring & evaluation of disability equality work undertaken in Hounslow Homes

Plans for 2007/8:

- Complete programme to make all sheltered units accessible for disabled residents
- Further staff to be trained in use of BSL & receive disability equality training
- Conduct mystery shopping to highlight gaps experienced by disabled customers in accessing our services
- Begin pilot project on Convent Way to stop misuse of disabled car parking spaces by non blue badge holders
- Increase the membership of the Hounslow Homes Disability Forum
- All new build properties to be compliant with disability regulations
- Hounslow Homes fully accessible website to be re-launched in early 2008
- Further improve "self service" by making more of our services to customers accessible via our website.
